- Each division is limited to 8 teams. Please note that more invitations have been sent than spots available in each division.
- Team rosters should be limited to 10 players as there will only be 10 awards distributed.
- All players on the roster need to be of Asian descent and can only be listed on one team roster. Players appearing on more than one roster will disqualify that individual from the tournament.

**ROSTER CHANGES:**

- After March 9, 2009, only teams considered being in hardship status (7 or less players) may request roster changes to replace unavailable players. All hardship requests must be made in writing to the Division Coordinator who will submit the request to the Tournament Committee for approval.
- Roster changes must be permanent additions to your roster. If the addition replaces a listed player on the roster, the original player listed cannot be reinstated and cannot play any games in the Tournament.
- Both organizations reserves the rights to accept, move, or reject teams based on what is in the best interest of the tournament.
