

S.F. ASSOCIATES 2011-2012 BASKETBALL APPLICATION

The Associates is a volunteer organization, and membership in the Associates requires full participation by families and players. Membership commitments, along with the Associates Goals, Code of Ethics, and Rules of Conduct, are described in the application. It is critical that all applicants understand and agree to fulfill these responsibilities.

Please fill out and return the attached application forms if:

- You are currently an Associates member and intend to play basketball during the 2011-2012 season; or
- If you would like to add your name to the waiting list to possibly begin playing with the Associates for the 2011-2012 Season.

Annual Fees:

- **Registration fee** for the 2011-2012 Basketball Season is \$100 per player for all ages. This fee is non-refundable after September 1, 2011 and is due with the application.
- **Membership fee** for the 2011-2012 Basketball Season is for all ages and is due at the beginning of the season as follows:
 - \$300 per player
 - \$450 for 2 siblings
 - \$600 for 3 and more siblings
 - \$225 per player for open season only
- **Ad fee** for the 2011-2012 Basketball Season is \$50 per player and is due in January.

The annual membership fee covers the cost of equipment, insurance, gym time for practices, administrative and incidental costs.

By mid-August, returning members will be notified of plans to start the 2011-2012 Basketball Season. New applicants will be notified of their status by mid to late August.

The completed application form and the \$100 annual registration fee (make check payable to S.F. Associates) are due as follows:

- 1) For **current Associates members**, submit your application and the \$100 registration fee to your team manager before **May 21, 2011**. The team manager is responsible for collecting and submitting the team member applications and fees on or before the **May 21st Coaches Appreciation Day**.

Associates Philosophy and Goals

Code of Ethics

It is the duty of all concerned with the Associates to emphasize the proper ideals of sportsmanship, ethical conduct and fair play. Athletes, coaches, managers and parents are expected to respect the integrity and judgment of officials, to show courtesy to visiting teams, and to recognize that the purpose of the game is to promote the physical, mental, moral, social, and emotional well-being of the athletes.

The Associates members (including participants, their parents, coaches and managers) represent the Associates and are the Associates ambassadors at each event. As such, they are to adhere to the following rules and responsibilities.

Rules of Conduct

- 1) Members are to conduct themselves in a sportsmanlike manner, emphasizing the proper ideals of sportsmanship, ethical conduct, and fair play, both on and off the field of the event while they are representing the Associates. Members are to refrain from the use of profanity or "trash" talking while at an Associates function.
- 2) Members will show courtesy to the officials, coaches and managers and will not direct abusive or profane language to them or undermine their authority. Members are expected to respect and listen to their coaches, managers and parents supporting the Associates at all times.
- 3) Each player is expected to attend all practice sessions and games. If unable to attend, they are to contact their respective coach(es) ahead of time (24 hours). If this is not complied with, it is the discretion of the coach and/or manager to enforce predetermined penalties. Unjustified absences or missed practices may result in the player's inability to play in games. This could ultimately result in a forfeiture of a game that will affect the other players.
- 4) As a team, members are to monitor each other and are expected to keep in line fellow team members who are not representing the Associates in the proper manner.
- 5) Members are to keep a positive outlook about the Associates program. Any criticism will be directed to the team manager, the Division Commissioner or a member of the Associates Steering Committee.

Parent and Player Membership Commitments

MEMBER AGREEMENT

In addition, I agree to indemnify, defend, protect, and hold harmless the ASSOCIATES and the JCCCNC from and against all claims, damages, liabilities, losses, and expenses, including but not limited to attorney' fees, in whole or in part, arising out of, resulting from or in connection with my child's participation in any activities sponsored by the ASSOCIATES, even if such claim, damage, liability, loss or expense should arise from the negligence of the ASSOCIATES. However, my agreement to indemnify, defend protect, and hold harmless in the preceding sentence shall be applicable only to the extent insurance proceeds paid by insurance carried by the ASSOCIATES does not cover the amount of the claim.

If the applicant deviates from this liability waiver and indemnification policy, I understand that the applicant can be suspended from future ASSOCIATES activities.

My child has my permission to be filmed or photographed as a participant of the Associates for publicity / program purposes. I understand that no compensation will be provided.
