The Associates is a volunteer organization and membership in the Associates requires full participation by families and players. Membership commitments, along with the Associates Goals, Code of Ethics, and Rules of Conduct, are described in the application. It is critical that all applicants understand and agree to fulfill these responsibilities. Parent participation is mandatory and is essential to our organization's continued success.

Please fill out and return the attached application forms if:

- You are currently an Associates member and intend to play basketball during the 2017-2018 season; or
- If you would like to add your name to the waiting list to possibly begin playing with the Associates for the 2017-2018 Season.

Annual Fees\*:

- **Registration fee** for the Basketball Season is **\$125** per player for all ages.
  - For League play, this fee is due with the application and is **non-refundable** after **August 31st, or acceptance.**
  - For Open play, this fee is due with the application and is **non-refundable** after **December 1st, or acceptance.**
- \*Fees will be returned for applicants that were not accepted.
- **Membership fee structure** for the Basketball Season for returning and new members accepted.

- **Late fee:**
  - o Additional late fee of **\$25** per player will be applied for membership fees not received when due.
  - o Additional late fee of **\$25** per player will be applied for decision changes between League vs Open.

The annual registration and membership fee covers the cost of equipment, insurance, gym time for practices, allotted league referee fees, allotted tournaments and league fees, uniform costs, administrative and incidental costs. No refunds of registration fees after August 31st for League, and December 1st for Open. No refunds of membership fees will be considered after the start of the season unless there is a documented medical reason. **NO EXCEPTIONS.**

Notification:

- Returning league members will be notified of plans to start the season by the end of August.
- New league applicants will receive confirmation of receipt and/or notified of their status by mid-September. Please note that due to the large number of new applicants in some age groups, not all applicants may be accepted.

The completed application form and the \$125 annual registration fee (make check payable to S.F. Associates) are due as follows:

- 1) For **current Associates league members**, submit your application and the \$125 registration fee to your team manager before or on **June 3, 2017**. For Open play, submit your application and the \$125 registration fee before or on November 1, 2017.

## **Associates Philosophy and Goals**

The Associates philosophy is to provide a healthy, nurturing organized sports environment for Nikkei and Asian youth, which enables participation in high quality, competitive athletics in a team sport atmosphere.

The Associates strive to develop in our youth the basic values of:

- Respect for individuals--teammates and competitors alike
- Discipline under the team concept
- Pride in one's self, team, organization, and community
- A sense of healthy competition
- Community service

We hope to see our youth grow not only as athletes, but also as individuals, who love the game, appreciate the opportunity to play, and uphold the Associates values and proud tradition.

## **Code of Ethics**

It is the duty of all concerned with the Associates to emphasize the proper ideals of sportsmanship, ethical conduct and fair play. Athletes, coaches, managers and parents are expected to respect the integrity and judgment of officials, to show courtesy to visiting teams, and to recognize that the purpose of the game is to promote the physical, mental, moral, social, and emotional well-being of the athletes.

The Associates members (including participants, their parents, coaches and managers) represent the Associates and are the Associates ambassadors at each event. As such, they are to adhere to the following rules and responsibilities.

## **Rules of Conduct**

- 1) Members are to conduct themselves in a sportsmanlike manner, emphasizing the proper ideals of sportsmanship, ethical conduct, and fair play, both on and off the field of the event while they are representing the Associates. Members are to refrain from the use of profanity or "trash" talking while at an Associates function.
- 2) Members will show courtesy to the officials, coaches and managers and will not direct abusive or profane language to them or undermine their authority. Members are expected to respect and listen to their coaches, managers and parents supporting the Associates at all times.
- 3) Each player is expected to attend all practice sessions and games. If unable to attend, they are to contact their respective coach(es) ahead of time (24 hours). If this is not complied with, it is the discretion of the coach and/or manager to enforce predetermined penalties. Unjustified absences or missed practices may result in the player's inability to play in games. This could ultimately result in a forfeiture of a game that will affect the other players.
- 4) As a team, members are to monitor each other and are expected to keep in line fellow team members who are not representing the Associates in the proper manner.
- 5) Members are to keep a positive outlook about the Associates program. Any criticism will be directed to the team manager, the Division Commissioner or a member of the Associates Steering Committee.

## **Mandatory Parent and Player Membership Commitments**

- 1) Annual registration and membership fees.
- 2) MANDATORY team duties, including but not limited to scorekeeping, timekeeping, team snacks, hotel arrangements for out-of-town tournaments, tournament applications, end of season team celebration.
- 3) MANDATORY parent participation for the Associates tournament and Jamboree, including scorekeeping, timekeeping, set up, clean up, concessions, donated food/money for social, etc. Based on your expertise, you will be assigned duties which may include but not limited to duties for your team or at the organizational level such as photographing teams at games, help maintain the website, preparing foods for the concessions for the Associate tournament and Jamboree, set up and take down duties, event planning, coordination duties, participate in various committees, community service events, etc.

- 7) Attend end of season Coach Appreciation celebration.
